## **NC Economic Development Structural Changes**

Governor McCrory signed a bill last month authorizing the establishment of a new public private partnership that will work on business recruitment, existing industry services, and travel and tourism. This is a key priority for the Governor to create a more flexible, nimble organization to be even more responsive to growing the NC economy. Some former state employees will transfer to the new entity and others will be hired. It will be funded by both public and private dollars and report to the Secretary of Commerce.

Many functions will remain with the public Commerce Department, including financial assistance programs, research, rural development programs, and workforce development. The two agencies will work cooperatively with complimentary roles.

The legislation established eight regional prosperity zones across the state and require that state and state related agencies such as Commerce, Transportation, DENR, and the Community Colleges work together to respond to economic development opportunities. Randolph County will remain in the Triad zone.

The state also eliminated funding to the former regional partnerships that provided marketing and research support to regional county groups. The new prosperity zones will have a different function, more on the line of a one-stop center aligned to meet the regional economic development needs in specific regional geographies.

These are big changes and already having an impact on our work. The great news is that our clients' needs will be served in an efficient and seamless process with all parties committed to cooperation and a timely response. We will stay focused on job creation, business investment and delivering great customer service to our existing industries.

As President of RCC, he led the winning campaign to adopt a voter approved 1/4 cent sales tax increase to fund needed capital needs at the community college and restructured the program in 2014 for a more focused emphasis on workforce development.

### **Business News & Announcements**

**Hughes Furniture Industries** will expand its upholstered furniture operation to the former Energizer building on Central Avenue in Asheboro. HFI is one of the largest private employers in Randolph County with most of its operation in Randleman. The 152,000 square foot facility will accommodate growth driven by its Quick Ship program that delivers customer orders within 72 hours.

**Ambella Home Collection** plans to acquire the former 47,000 square foot Currin building in Archdale for its first manufacturing operation. The Dallas Texas based company designs, sources, and sells case goods with all manufacturing conducted off-shore. The project would create a new upholstery operation with 12 full time employees. The building has been vacant for 20 months and the City of Archdale has applied for a building reuse grant to assist with the costs of repairs.

**Kraftsman Inc.** will expand its specialty utility and equipment trailer business on US 64 east of Ramseur. The company plans to add 16,250 square feet to its existing operation. Started in 2000, the company has supplied specialty trailers for homeland security and public safety as well as industrial and commercial uses.

**PetPro Resources LLC** is planning a new manufacturing operation to produce pet food and animal feed ingredients at the former Lucks/Seagrove Foods plant in Seagrove. The start-up company plans to convert NC grown sweet potatoes and poultry parts to a flour / powder consistency. Randolph County has applied for a building reuse grant to assist with the cost of a roof mounted solar installation for energy production due to the lack of natural gas.

### **Congratulations**

**Harold Holmes** was named the 2014 Partner in Progress at the EDC Annual meeting in recognition of his many years of service to Randolph County and his rock solid commitment to economic development and positive growth. Holmes is not running for reelection to the County Commission, a position he has held for 20 years, the last 11 as Chairman.
