# **RCC Welding Program Expanded**

On September 5, Randolph Community College hosted a ribbon cutting to celebrate the expansion of the welding lab at the college's Archdale Center. There are now thirty-one welding booths at the lab, allowing for training of eleven additional students at any one time. With trained welders in high demand, the expanded program can help ensure that local employers are able to hire employees trained right here in Randolph County. Students can earn credentials, certifications, and even an

Congratulations are in order for two Randolph County manufacturers that have been named among the Triad Business Journal's 2019 Fast 50 winners. Randlemanbased Alumiworks, which fabricates and installs custom stairs and rails, came in at number 19 on this year's list. Asheboro-based Founder's Hemp is seeking funds to facilitate growth in one of its Asheboro facilities. The company will renovate existing space, constructing five new clean rooms to expand its extraction capacity. The clean rooms will meet the supplement grade processing standards. Total investment in the project including machinery and equipment is anticipated to exceed \$400,000, and the company is committed to creating at least fifteen new jobs with an

average annual wage of \$35,667. The City of Asheboro has approved submission of a Building Reuse Grant application to NC Commerce in the amount of \$150,000 to assist with renovation expenses. Grant awards will be announced on October 17.
